Dear Colleagues,

Neuropsychologists are deeply impacted by the pandemic given the special services you provide. We wanted to alert you of our efforts to team with other organizations representing the discipline to advocate for you and provide you with helpful information.

As you may know, we are a member of the Inter Organizational Practice Committee (IOPC), which is a coalition of representatives of the major Neuropsychology organizations in the US. The member groups are the American Academy of Clinical Neuropsychology (AACN), Division 40 of the American Psychological Association (APA), the National Academy of Neuropsychology (NAN), the American Board of Professional Neuropsychology (ABN), and the American Psychological Association Services, Inc.

Over the years, the IOPC has joined forces on numerous occasions to nimbly and rapidly provide resources and expertise to advocate to improve the practice climate and access to high quality neuropsychological care for our patients. In light of dramatic access to care issues due to the coronavirus pandemic, our IOPC member organizations have activated an IOPC COVID-Tele-neuropsychology advocacy team. Team members include national experts in CPT coding and reimbursement, technology, large group practices, regional private insurance/ Medicare, primary care neuropsychology, access for multilingual/multicultural populations, APA Practice healthcare finance and APA Practice legal staff.




